### Remarks:

The board of directors of the Company approved the A shares repurchase plan on 19 May 2022 and such repurchase plan has ended on 11 October 2022. A total of 87,265,525 ordinary A shares were repurchased during 24 May 2022 to 11 October 2022, but not cancelled. 78,270,000 of the repurchased A shares had been granted to 693 qualified incentive participants at a price of RMB6.264 per A share on 8 December 2023 pursuant to the Company's restricted share incentive scheme of A shares ("Incentive Scheme"), and the grant of such A shares was completed on 20 December 2023. Please refer to the announcement of the Company dated 20 December 2023 for further details.

As disclosed in the announcements of the Company dated 2 July 2025 and 8 August 2025, the Board the board of directors of the Company has approved the proposed repurchase and cancellation of all of the granted but not unlocked Restricted Shares held by the fourteen Incentive Participants in the total number of 2,090,000 A Shares pursuant to the authorization of the Shareholders at the general meeting, A share class meeting and H share class meeting held on 10 February 2025. All such A shares have been repurchased and cancelled on 30 September 2025.
